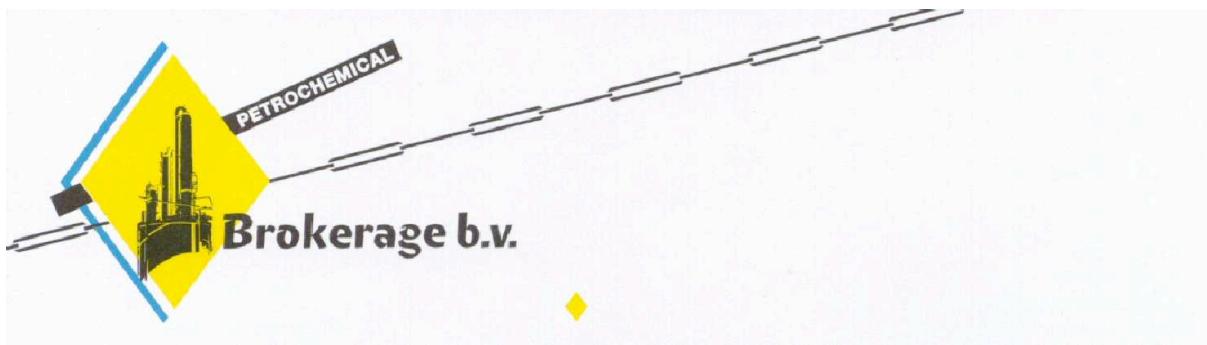
We abide by the General Regulation data protection (AVG). The AVG has 2 principles for the processing of personal data regarding Petrochemical Brokerage B.V.:

To conclude a deal we process the following personal data by allowing you to use our services :

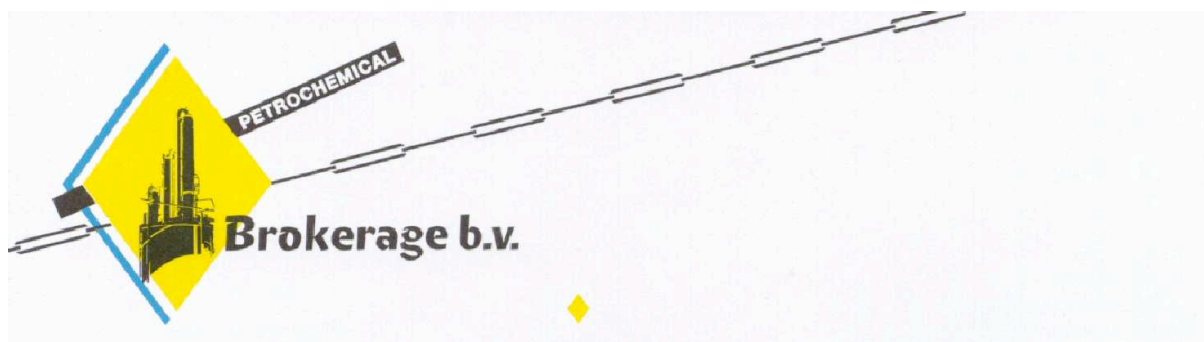

If there is a relationship develops, for example, by the decrease of a product the data will be stored for the duration of the relationship plus up to seven years after termination of the relationship.

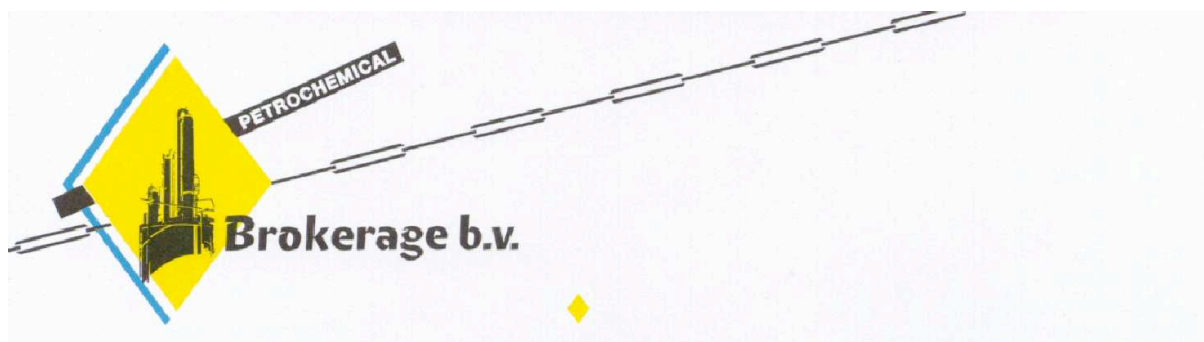
Sharing of personal information with third parties
